ollowing the success of last year and the renewal of Scotland's Fair Trade Nation status, we have had another great year. Scotland's commitment to Fair Trade has grown and flourished with the continued support of our partners and local campaigners.

The Forum has continued to develop relationships with public sector organisations and to support the education sector at early years, school, college and university level. There have been many great achievements including the University of Strathclyde gaining Fairtrade status in June 2017.

We continue to support a wide network of committed campaigners and Fair Trade organisations across Scotland. Two more local authority areas, Dumfries and Galloway and South Ayrshire, were awarded Fairtrade Zone status by the Fairtrade Foundation during the year.

## **REVIEW OF THE YEAR**

This year, our Campaigner Conference was held in Perth. We were joined by Fair Trade campaigners from across Scotland and beyond who were keen to address the theme of the conference: 'Fair Trade in Context: Challenges and Opportunities'. The conference hosted speakers from the Forum, the Fairtrade Foundation, the All Party Group on Fairtrade from the Northern Irish Assembly, the Trade Justice Movement and the International Development team at the Scottish Government.

It was great to be part of the Fair Trade Fiesta on Saturday 13 May 2017 to celebrate World Fair Trade Day. The Fiesta, organised by Hand Up Events, featured a carnival parade on the Royal Mile in Edinburgh followed by a music concert at the Ross Band Stand in Princes Street Gardens. The event was attended by Rudi Dalvai, President of the World Fair Trade Organization and Dr Alasdair Allan, Scotland's Minister for International Development and Europe, both of whom wore items from the World Fair Trade Tartan collection.

The Scottish Fair Trade Awards ceremony, this year held in Paisley and hosted in partnership with

Rainbow Turtle, recognised the work of volunteers, campaigners and organisations in promoting Fair Trade. This year's Fair Trade Nation lecture took place in May 2017 at City of Glasgow College, delivered by



Professor Bob Doherty of the University of York, on the subject of 'The Food System and Fair Trade.'

We have maintained our partnerships with Scotland's International Development Alliance, the Scotland Malawi Partnership, the Development Education Centres, the Fairtrade Foundation and Fair Trade Wales, and developed our relationship with Fair Trade campaigners in Northern Ireland and Fair Trade networks globally.

The Forum continues to move forward stronger than ever. We have much to do but with the work that we have done over the years, the strength of our partnerships and our public and political support, we are in a strong position to build a more dynamic, thriving and successful Fair Trade market in Scotland.

# **FAIRTRADE FORTNIGHT 2018**

airtrade Fortnight 2018 ran from 26 February to 11 March with a great deal of superb events taking place across our Fair Trade Nation. Campaigners from Dumfries to Orkney showed their support for producers and Fair Trade by organising a range of activities and campaigns in their communities. Events included coffee mornings, treasure hunts and wine tastings, many of which took up the Fairtrade Foundation's 'Come On In' theme.

The Scottish Fair Trade Forum worked directly with Mzuzu Coffee Planters Co-operative Union in Malawi to facilitate a visit from Bernard Kaunda (Acting Chief Executive of Mzuzu) and Christopher Gondwe (Quality and Processing Executive) to Scotland during the Fortnight. Mzuzu champions the economic empowerment of their smallholder farmers and has been Fairtrade certified since 2009.

Bernard and Christopher's visit coincided with the "Beast from the East" snowstorm which thwarted planned visits to St Andrews, Stirling, Perth, Dundee and Aberdeen. When the weather let up, Bernard and Christopher participated in events in Edinburgh,

Renfrewshire, Hamilton and North Lanarkshire. On the final day of their visit, Bernard and Christopher attended a Commonwealth lunch event at Edinburgh City Chambers hosted by the Scotland Malawi Partnership.

During their visit, Bernard and Christopher also met WFTO Guarantee System Member, Fair Trade Scotland Limited, with whom they are now pursuing a partnership to bring Mzuzu coffee, with the WFTO Product Label and the Fairtrade Mark, to Scottish consumers.

Tania Pramschufer (Hand Up Events) and Eve Broadis (Fair Trade Scotland Limited) for the World Fair Trade Tartan campaign. Eve and Tania have worked directly with producers in Cambodia and organised prominent events to promote the tartan.

## Community Award

**Albyn School Fair Trade Group** for their commitment to being a Fairtrade School and working with local groups to reach diverse parts of the community.
