conference gather in Glasgow and it was a privilege to meet the delegation of Fairtrade producers who came to Scotland. Yet despite some progress at COP26, we see the climate crisis continue. What was clear from our partners in the Global South is that they continue to be the ones most directly feeling the detrimental impact of climate change and also the ones leading the way in highlighting the practical solutions. Yet they are too often not listened to nor in many cases even invited to the table for discussions. The Fair Trade

movement has at its heart the commitment to empowering marginalised producer groups, workers and small-holder farmers. Over the last year, we,



as Fair Trade supporters in Scotland, have continued to join our voices with those around the globe calling for trade justice in order to achieve climate justice. In the year ahead we will re-double that effort to achieve the change we need."

This year's Fairtrade Fortnight picked up where COP26 left off and asked us all to choose the world we want to see by buying Fairtrade to support farmers during the climate crisis.



We hosted two climate change events for Fairtrade Fortnight. One to explore Fairtrade's bigger picture in the debate surrounding the carbon cost of consumption; and one highlighting the greater impact of climate change on women. Both events gave a voice to producers and farmers, including women involved in agriculture and both events concluded that Fairtrade is a choice for people and the planet. It's one of the ways of consuming ethically; and it gives women farmers the opportunity to offer solutions to the climate crisis. You can watch both events on our **YouTube Channel**.





Ministerial Message

"Last Autumn the 26th UN Climate Change Conference of the Parties brought governments, civil society, businesses and climate activists together to commit to greater action on climate change. COP26 was one of the most important events to be held in Scotland, and for 14 days the eyes of the world were on Glasgow.

I am proud of what was achieved during those two weeks. In addition to the Glasgow Climate Pact and the Scottish Government's commitment to treble our Climate Justice Fund, the First Minister also announced a novel new Loss and Damage Fund. This fund will provide additional financial support for the world's poorest and more vulnerable communities in their efforts to tackle the impacts of climate change. However, with both climate change and COVID-19 continuing to have a devastating impact on the world's most marginalised people, including women and young people, it is only right, ahead of COP27, that we strive to amplify the voices of the people from those marginalised communities in the Global South in climate change discussions.

Fair Trade Farmers are dealing with the sharp end of the climate crisis, whilst at the same time leading the way with sustainable solutions. That is why we must respond to their demand for financing to reach farmers and workers directly, to plant trees, introduce more resilient crops, and adapt to farming through the climate crisis while continuing to grow the world's food. And it is why we must seek to connect them with global decision makers and ensure they have a seat at the table.

We place great importance on Scotland being a good global citizen and I'm proud of how the Scottish Government has risen to the challenges of the last 12 months. Not just in the



way we supported the people of Scotland through the pandemic and some of our country's most difficult days, but in the way we continued to play our part in supporting our partner countries through some of theirs. We did this through, not just maintaining but increasing, our Climate Justice Fund and our International Development Fund.

Fair Trade, and Scotland's status as a Fair Trade nation, is a significant component of our support for international development, and awareness amongst the people of Scotland of the importance of global solidarity, the impact the climate crisis is having on farmers, and how Fair Trade makes a difference through its focus on people and planet before profit, has been a big part of the Scottish Fair Trade Forum's work over the course of the last year.

I value the relationship we have built with the Scottish Fair Trade Forum since the Scottish Government first began funding the organisation in 2007, and I'm thankful to their members who continue to support the Forum as they work to promote Fair Trade and build support for the renewal of Scotland's status as a Fair Trade nation. I look forward to working together in the months and years ahead."

The Scottish Fair Trade Forum 2021-22 Highlights #tradejustice4climate

During COP26 in Glasgow, we represented our Fair Trade Nation by attending official events, creating a **short film** and releasing "The Faircast" podcast.

Our Fairtrade Fortnight events have engaged over 1,200 people hearing from 7 Fairtrade farmers from Ghana, Malawi, Ethiopa, Sri Lanka, Kenya, Rwanda and Palestine.

Over 400 people have listened to our **Fair Trade Nation Lecture**, with Sir Geoff Palmer about Slavery and Fair Trade.

We were involved in two professional learning sessions for teachers with Fairtrade Schools and the One World Centre. The sessions explored Fair Trade and Climate Change in the classroom.

We continued our online regional meet-ups with 80 Fair Trade campaigners from 6 regions.

The Cross Party Group on Fair Trade was re-established in the Scottish Parliament after the 2021 Scottish Parliament elections.

We were delighted to welcome three new Trustees and two new staff members during the year.

We successfully partnered with Ollema Fairer Farming Ventures to form **The Alternative Coffee Company** and have engaged with over 20 Scottish roasters.

We provided grant support to 8 Scottish Fair Trade businesses.

Cross-Party Group on Fair Trade

Activities and Impact

AIM 1: Developing a HUB OF EXPERTISE for Fair Trade in Scotland

Matters arising

Following the Scottish Parliament elections in May 2021, the Cross Party Group (CPG) on Fair Trade was reconvened. The CPG brings together MSPs and interested individuals and organisations to discuss policy. Colin Smyth MSP was re-elected as Convenor and Sue Webber MSP as Vice Convenor. The Scottish Fair Trade Forum was again asked to take on the secretariat role for the Group. CPG members agreed that the two key priority areas for this parliamentary session will be the climate crisis and public procurement.

We have continued work with Fair Trade Wales to look at refreshing the Fair Trade Nation criteria to reflect the changes in business, campaigning and society since the criteria were first developed over 15 years ago.



Fair Trade Pledge

- → We will continue to advocate for trade justice alongside climate justice, working with sustainability organisations to highlight both the impact of the crisis on farmers and workers, and Fair Trade's role in leading the way with solutions.
- → We will keep asking MSPs to support the **Fair Trade Pledge**, and we will extend this ask to Council leaders in order to increase support for Fair Trade in Scotland.

Procurement

To mark Fairtrade Fortnight, we held a roundtable on Fair Trade and public procurement. We brought together over 20 representatives from public contracting authorities and Fair Trade suppliers, to share learning and plan for the future.



We remain committed to monitoring spending on Fair Trade and will be publishing reports from the last 3 years later in 2022. These reports seek to support Scotland's public sector to increase spending on Fair Trade and strengthen Fair Trade policy commitments.

Investing in Partnerships

The Fair Trade movement has long recognised the importance of fair value and inclusive and lasting partnerships. With this in mind, last year with small grants, we supported 5 Scottish-based enterprises to develop small, yet creative and impactful project ideas that invested in partnerships with Fair Trade producers and workers.

WFTO Kickstart

We supported 3 Scottish based Fair Trade social enterprises to apply to become WFTO Guaranteed members. Putting people and planet first in everything they do, we're looking forward to seeing Fair Business Alliance, Gogo Olive and Sisal Tech become part of the growing WFTO global community.



AIM 2: Increasing THE MARKET FOR FAIR TRADE goods in Scotland

The Alternative Coffee Company

We worked in partnership with Ollema Fairer Farming Ventures to establish <u>The Alternative Coffee Company</u>. This social enterprise start-up aims to offer a sustainable route to market for Fairtrade Rwandan and Ugandan specialty coffee. Through online events, visits, and mapping activities, we have been able to engage with over 20 Scottish roasters.

Building on the success of the Rwanda Coffee Project, delivered in partnership with Challenges Worldwide, The Alternative Coffee Company has been able to develop pre-existing relationships with Rwandan co-operatives and continue to build the market for Rwandan coffee here in Scotland.

AIM 2: Increasing THE MARKET FOR FAIR TRADE goods in Scotland

Ethical marketplace

We continued to work with Rainbow Turtle and Ollema Fairer Farming Ventures to explore the potential for "Fair, Green and Scottish" online ethical marketplace.





- → With the impact of COVID-19 and inflation hitting ethical businesses hard, we see a need for an online marketplace that can platform "Fair, Green and Scottish" businesses, and goods. We are exploring funding and partnership opportunities for the development of this marketplace and will engage with key stakeholders in the sector to catalyse its creation.
- → The specialty coffee market is booming, and we will continue to campaign for the need for Fair Trade coffee within it. We seek to build lasting partnerships with coffee roasters in Scotland and encourage cafes to support their local roaster as part of Building Back Fairer. We will be focusing on selling the landed coffee we have available now and placing orders for the next crop year. We will host farmer-roaster online events, so that lasting trading relationships can be built and maintained.
- → Building on the success of the WFTO Kickstart programme, we are now working in partnership with WFTO Africa to support 3 Malawi-based Fair Trade enterprises on their journey to becoming WFTO Guaranteed members.

AIM 3: Engaging Scottish COMMUNITIES in support of Fair Trade

Building awareness of the impact of the climate crisis on farmers and how Fair Trade makes a difference through its focus on people and planet before profit has been a big part of our engagement of communities, especially with COP26 in Glasgow in November 2021.

→ For COP26, we were signatories to a statement putting forward the case that the international community must confront trade injustice, enforce transparency and accountability in supply chains, and secure climate financing mechanisms, living incomes and wages for the world's smallholder agricultural producers, artisans

and workers in order to successfully address the climate crisis and guarantee a sustainable future for all.

- → We produced a **short film** for COP26 with input from the World Fair Trade Organisation and the Fairtrade Foundation, along with Scottish Fair Trade campaigners to give a voice to Fair Trade farmers for COP26 - the film has been viewed over 1,000 times.
- → Our Fairtrade Fortnight events that highlighted Fairtrade as a guaranteed ethical choice for consumers; and women as a solution in tackling climate change, were attended by over 100 people and have been viewed online over 1,100 times.



→ The Faircast, our podcast for COP26, where we spoke to a number of very interesting Fair Trade advocates doing their bit to make the world more sustainable in 5 episodes has been downloaded 500 times.



→ Our 6 regional sessions across the country when we met up with 80 Fair Trade campaigners focused on Fair Trade and climate change – both the impact of the crisis on farmers and Fair Trade as a solution.



Fair Trade and Young People

We carried out some research this year to find out what young people think about Fair Trade and what gets them campaigning. More than half of those surveyed would buy a product if they knew it was Fair Trade but there is a lower

awareness of Fairtrade gold, flowers and beauty products among the age group. Those surveyed care about climate change, global poverty and women's rights and have an interest in the link between these issues and Fair Trade.

Online events and producer voice

Our online events continued and allowed us to engage with more than 10 Fair Trade producers, 7 of those during Fairtrade Fortnight from 5 different countries. Their input is vital and we will continue to engage producers, farmers and workers in our online events, and to listen to their voices and requests.

"We use pits with coconut husks to collect rainwater." Sriyani, Sri Lankan coconut farmer (speaking about how they deal with droughts). "A proper water collection and retention project will be very valuable..." The coconut producers plan to use the Fairtrade premium to support them as they tackle the impacts of climate change.

Scottish Fair Trade Awards 2021

This year, to mark COP26, we had two awards that recognised those working simultaneously on climate justice and trade justice – the Fair Trade and Sustainability Award and the Climate Partnership Award. We were delighted to have 12 winners across 7 award categories, representing the continued dedication of volunteers, campaigners, businesses, nurseries, schools, teachers, colleges and universities, local authorities and faith groups to our Fair Trade Nation.

- → Young people are not necessarily interested in coming along to Fair Trade meetings but they are interested in the link between climate change, global poverty and women's rights and would like to know more about this. We will continue to work to raise awareness of the relevancy of Fair Trade to other campaigns.
- Campaigning for trade and climate justice takes Fair Trade to new audiences and demonstrates the impact now of climate change on those who produce our food, and other products we buy.
- → Producers tell the story of Fair Trade and the solutions it offers to people and planet better than anyone else and we must advocate for their voices to be heard, and provide a platform to hear those voices.
- → We aim to increase the number of people attending regional events and to facilitate the sharing of ideas to inspire Fair Trade campaigning.

AIM 4: Encouraging quality EDUCATION on Fair Trade

We linked up with Fairtrade Schools and the One World Centre to deliver two professional learning sessions for teachers exploring Fair Trade and Climate Change in the classroom this year. One session took place in the run up to Fairtrade Fortnight and **The Big Fairtrade CPD** was delivered as part of the Choose The World You Want Festival, with input also from members JTS and Koolskools.

- → Our future education work with schools will be delivered in partnership with the Development Education Centres who work with teachers interested in global citizenship and who are experts in professional training. We will continue to add value with our knowledge and understanding of the 10 Principles of Fair Trade.
- → We are currently working with a consultant on the direction of our schools, adult and workplace education work to ensure we are able to make the greatest impact with the resources we have.

AIM 5: Improve our SUSTAINABILITY and maintain GOOD GOVERNANCE

Our plan to diversify our income base continues and our non-government grant income is over 20% of our total income. In order to develop further our income generation work, supplying advice and consultancy services, proposals have been developed to establish a trading subsidiary.

We have increased our member numbers this year and are delighted to welcome all new and renewing members. Thank you also to South Lanarkshire Council, Scotmid and the Energy Agency who sponsored the Scottish Fair Trade Awards.

Our last AGM saw the election of two new Board members: Pam Robinson of Montrose Fair Trade Forum and Andy Ashcroft of Koolskools.
